REQUEST FOR QUALIFICATIONS

Mechanical and Functional Upgrades to the Litchfield Middle School

The Litchfield School District (The District), Litchfield, NH, is seeking a Construction Manager as Constructor (CMc) to assist The District in planning and upgrades to the Litchfield Middle School (LMS). The District is working with Windy Hill Associates, Architects and Design Day Mechanicals, Inc. and intends to engage a qualified Construction Manager for pre-construction and construction services to upgrade the existing mechanical system from hydronic to Heat Pumps, to upgrade the existing ventilation system, replace the existing Control System, to re-roof and add a solar array, add battery back-up, to replace windows, minor functional and cosmetic upgrades, and site drainage upgrade. Schematic Design drawings are currently being developed.

The intent is to phase the project by replacing windows, roof and HVAC 1 in summer 2021 and perform the balance of upgrades in summer 2022. The total project budget is expected to be about \$3.5 - \$4 Million. A performance bond will be required. The selected CMc will be expected to enter into A133-2019 Standard Form of Agreement Between Owner and Construction Manager as Constructor where the basis of payment is the Cost of the Work Plus a Fee with a Guaranteed Maximum Price.

The District will be asking the selected CMc to provide budgeting, meeting attendance, feasibility, and other pre-construction services. The CMc will be expected to work in the owner's best interest to solicit subcontractor and materials bids to develop a cost effective budget and strategy to implement the project. The CMc will continue with The District through construction phases to implement the Work using a combination of the CMc's forces and sub-contractors.
